# "5th Subsidy Programme for the Production of Original Song Albums" Rectification Notice

Revised contents are as follows:

- 1. The application rules and forms for the "5<sup>th</sup> Subsidy Programme for the Production of Original Song Albums" uploaded by the Cultural Affairs Bureau on their website on 16 July, 2020 have been revised as follows:
- Deadline for the Initial Review: extended from 30/09/2020 to 15/10/2020
- Clause 6.1.4 in the Application Rules
