

## "2021 hush! Summer Concerts" – Open Call for Local Bands and Musicians

#### **Introduction**

"hush!" is an important cultural brand and the most anticipated annual music event of the year that has a history of over 10 years in Macau! This year "hush!" will continue to promote the development of live music in Macau through summer concerts, inviting various local bands to perform different forms of music, creating a passionate and spirited musical extravaganza.

Activities: Concerts and thematic events, including workshops, art installation, online music competitions, cultural and creative bazaars and music-related productions and activities, mainly involving local musicians, bands, producers and performers.

#### 1. <u>Theme of the event</u>

Macau is a seaside city that has nurtured a maritime culture that is both seafaring and prosea, and is characterized by its open and outward-looking nature, embracing cultures from around the world, making it a unique cultural landscape. The "2021 hush! Summer Concerts" will highlight Macau's maritime culture, with performances along the coastline, from Ponte 9 at the Inner Harbour, Navy Yard, Macau Tower, Kun Iam Ecumenical Centre to the Science Center and other coastal locations in Macau.

#### 2. Date and venue of the event

Event Date : June 26 to July 11, 2021 Event Venue: Navy Yard n° 2, Ponte 9 Rooftop, Science Center Square, etc.

#### **<u>3. Categories for Participation</u>**

A. The types of music of the local bands and musicians should be mainly pop, and at least half of the songs and music performed must be original and performed on musical instruments. Local bands and musicians can participate in the following categories:

- "Hot Wave" : A marathon of concerts at the Science Centre or performances at the Navy Yard. Suitable for bands with more than 3 years of experience or musicians with extensive performance experience. Performance duration is between 30-45 minutes.
- "Upbeat Power": Young bands or independent musicians established for less than 3 years or with an average age of less than 26 years are cordially welcome to join Upbeat Power session. Performance duration is 30 minutes.
- 3) "Summer Chill": Performance on the rooftop of Ponte 9 at the Inner Harbour. The show features light music and artists can set their own themes according to their own musical characteristics. Suitable for bands that have been established for more than 3



years or musicians with performance experience. The duration of the performance is 30 to 45 minutes.

- 4) "hush! Kids" : A hush! Kids stage will be set up this year. Suitable for bands with an average age of 12 years or below. The duration of the performance is 20 minutes. The band can perform non-original songs and music.
- B. Or participate in below extended activities:
  - 5) "Music Workshop" : Participants can recommend a tutor to host music-related topic workshop.
  - 6) "Themed Music Development" : Local bands, musicians and curators can participate in the production of special performances and activities, which will be held at the Ponte 9 at the Inner Harbour, Navy Yard, Science Center and locations along the coast. The theme should be creative and able to promote the development of pop music in Macau.

#### 4. Evaluation Criteria

1) Originality and characteristics of the music	25 points
2) Attractiveness in performance	25 points
3) Degree of activity in popular music	25 points
4) Reasonability of the budget	25 points
B. "Music Workshop" and "Themed Music Development":
