## "hush! 2023 Concerts" - Registration Regulations

## **Introduction**

"hush!" Concert is an annual event in the Macao pop music industry and an important brand of local cultural events. This year "hush!" will continue to promote the development of live music in Macao in the form of multiple concerts, inviting various local bands to perform different forms of music, creating a passionate and spirited musical extravaganza.

Activities: Organization of various concerts and thematic events, including network connection, art installation, online music competitions, workshops, music booths, brand linkage and activities related to music, mainly involving local musicians, bands, producers and performers.

## 1. Theme of the event

Macao is a seaside city that has nurtured a maritime culture that is both seafaring and prosea, and is characterized by its open and outward-looking nature, embracing cultures from around the world, making it a unique cultural landscape. The "hush! 2023 Concerts", with this theme, will be using Hac Sa Beach as a base to highlight Macao's maritime culture.

## 2. Date and venue of the event

- 2.1 Date: End of October to early November 2023
- 2.2 Venue: Hac Sa Beach and outdoor and indoor venues in Macau Peninsula and Coloane Village

## 3. Categories for Participation

- 3.1 The type of music should be mainly pop and songs and music performed must be played on musical instruments and fall into the following 3 categories:
  - 3.1.1 Stage "Hot Wave": For bands with more than 3 years of experience or musicians with extensive performance experience. Performance duration is between 30-45 minutes and the music performed must be at least half original.
  - 3.1.2 Stage "Upbeat Power": For young bands or independent musicians established for less than 3 years or with an average age of less than 26 years old. Performance duration is 30 minutes and the music performed must be at least half original.
  - 3.1.3 Stage "Summer Chill": The show features light music and artists can set their own themes according to their own musical characteristics. Suitable for bands that have been established for more than 3 years or musicians with performance experience. The duration of the performance is 30 to 45 minutes and the music performed must be at least half original.
  - 3.1.4 Stage "hush! Kids":
    - a) for bands with at least one member aged 12 or below. The duration of the performance is 20 minutes. The band can perform non-original songs and music;

b) adult ensembles or art groups with children as the audience are also welcome to participate. The length of the performance is 20 to 30 minutes. The performances can be non-original songs and music.

## 3.2 Extended activities:

- 3.2.1 "Music Workshop": Participants can recommend themselves or a tutor to host music-related topic workshop.
- 3.2.2 "Themed Music Development": Local bands, musicians and curators can participate in the production of special performances and themed events. The theme should be creative and able to promote the development of pop music in Macao.
- 3.2.3 "Art Installation": Applicants use Hac Sa Beach and forest area as locations to plan, design and produce outdoor art installations to match the theme of the event.

## 4. Classification of applicants

Applicants can participate under the following five classifications:

- 4.1 As an adult band, group or musician
- 4.2 As a child performer in hush! Kids
- 4.3 As a music workshop tutor
- 4.4 As a curator in the development of thematic music projects
- 4.5 As a curator of art installation

## 5. Assessment Criteria

  - 5.1.1 Number of original compositions (10%)
  - 5.1.2 Quality of original works (10%)
  - 5.1.3 Number of overseas performances (10%)
  - 5.1.4 Number of awards (10%)
  - 5.1.5 Local performances by the band (10%)
  - 5.1.6 Band qualifications and characteristics (20%)
    (the number of years the band was established, the awards received by the band and its creators, the musical style and its uniqueness and the qualifications of the band members)
  - 5.1.7 Overall Performance (30%)
    - (Ensemble's understanding and stability, performance integrity, fluency, melody, difficulty, mastery of instrumentation or vocal technique, performance expressiveness, emotion, interpretation, creativity, stage presence)
- 5.2  $\lceil$  As a child performer in hush! Kids  $\mid$  the ratings are as follows:
  - 5.2.1 Band local activity (10%)
  - 5.2.2 Band characteristics (30%)
    - (the number of awards won by the band and its members, the type of music performed by the band and the uniqueness of the band in Macao)
  - 5.2.3 Overall Performance (60%)
    - (Ensemble's understanding and stability, performance integrity, fluency, melody, difficulty, mastery of instrumentation or vocal technique, performance expressiveness, emotion, interpretation, creativity, stage presence)

# <u>6. Funds generated from performances/workshops/thematic music development plan/art installation planning</u>

The scores of each applicant will be calculated based on the evaluation criteria in point 5 above in relation to the documents, participation information, reference budget and proposal submitted by the applicant to determine the shortlist and the funding received. The scope of funding is as follows:
