- Each artist can only submit one artwork. Any submission of more than one entry will not be accepted. 2.
- 3. Artwork must not be larger than 40cm x 40cm x 30cm. Electricity will not be provided.
- Artwork (including but not limited to texts, graphic and image) must observe the following rules: 4.
- 4a) Must not be made of food or any materials that fail to meet hygiene standards;
- Must not contain any obscene, indecent, defaming, threatening or erotic content, or elements that can cause harassment, discrimination, 4b) agitation for illegal activities, or breach of civil or criminal law;
- Must not be immoral, unethical, or harmful to the public interest or social harmony; 4c)
- Must not contain elements that violate the law, disparage the image of the Organiser or are harmful to the relationship between any countries 4d) or regions.
- Artwork must be the artist's original work and must not infringe on any rights of third parties (including copyright, confidentiality or privacy). In 5. the event of an infringement of the law, the artist shall bear all legal liabilities incurred thereof.
- Artwork that fail to observe any of the above-mentioned regulations will not be put on display and no notice will be given. 6.
- The Organiser will arrange the exhibition schedule for the artwork and notify the artist by phone. The artist may not request or object to the 7. assigned display period or duration.
- The Organiser has the usage rights of the artwork and can use the artwork for publicity purposes. 8.
- The Organiser will not bear any liability to compensate for any damage or loss of the artwork. 9.
- The Organiser reserves the right of final interpretation for matters not covered in this submission form.
